Terms and Conditions

The Liberty Business Network platform (LBN) is a registered trade name of Ignite Liberty, LLC (IL). All payments must be submitted to Ignite Liberty in check or credit card. Regardless of whether a partner business (PB) decides to sign a year-long or month-to-month contract, the entire contract is due and payable before the business will be listed on the LBN platform.

By being listed on the LBN platform, the PB may send coupons and advertisements out through the LBN network. The business agrees that the method and manner of dispersing those advertisements are at the sole discretion of IL. No guarantees are made or implied as to specific platforms, procedures, and timing of an advertisement's disbursement; however, IL will make a reasonable faith effort to meet the business's needs to the best of IL's ability.

At this time, no additional charges are required for sending coupons and particular advertisements through the LBN platform; however, that is subject to change and IL's sole discretion. IL will make a reasonable faith effort to inform partner businesses of any coming changes in the fee structure in advance. Any changes to the fee structure will not take effect until the commencement of a PB's new contract.

LBN intends to develop and launch a free app, in addition to its website, on the Google Play and Apple App Store. However, the partner business agrees that IL may change said app to a paid app at its sole discretion. The partner businesses will be notified in advance of this change. They will be allowed to express any concerns they may have about the change to IL before the decision is final. However, under no condition will a change in the app's fee structure warrant a change in the contract with partner businesses.

By joining LBN, the PB agrees to be bound by the following terms and conditions:

1. The PB pledges to honor and respect your customer's bodily autonomy by not requiring them to wear a face-covering of any kind against their will to enter your establishment.
2. The PB pledges to honor and respect your customer's bodily autonomy by not requiring them to show proof of vaccination for COVID-19, or any other communicable disease, to enter you establishment.
3. The PB pledges to treat, and serve, all customers with the same level of dignity and respect regardless of their personal medical decisions.
4. PB agrees to conduct all business in a manner to not bring discredit upon itself, LBN, or IL.

Grounds for termination of listing:

IL will investigate any customer complaint involving a business violating any of the above terms and conditions. Suppose it is determined that the complaint was warranted and that the PB has violated the above terms and conditions. In that case, the following actions may be taken:

1. First Offense: the PB will be issued a warning by IL and will issue an apology in writing to the offended customer.
2. Second Offense: the PB will be suspended from LBN listings for a period of 30 days following the infraction and will issue a public apology to the affected customers
3. Third Offence: the PB will be suspended from LBN listings for a period of at least six months or until IL is satisfied that the circumstances which led to the business's suspension no longer exist. Suppose at the end of that period, IL decides that the business no longer represents the principles that IL and LBN stand for. In that case, IL may, at its discretion, permanently suspend the business from being listed on or advertising its products and services through the LBN platform. In the event, a business is permanently suspended from the LBN platform, said business would forgo any remaining months on its contract with IL (if paid in advance). Any refunds for the remaining months on the contract will be at the sole discretion of IL, whose decision will be final. If the said business is on a month-to-month contract, the business will forgo the remainder of

that month, and no refund will be issued.

By joining the LBN platform, the PB agrees to provide copies of its logo, suitable for the web, and contact information for the business (address, phone number, email address) for the purposes of listing the business on the platform. PB agrees and licenses IL to use that logo in a manner that IL sees fit to advertise the PB products and/or services and the LBN platform. IL will in no way use PB logo in a manner that would be detrimental to the PB.

The PB will receive from IL a web-suitable logo recognizing the business as a member of LBN, as well as a window decal to be displayed in a conspicuous location at each of the PB's locations for the duration of its listing on the LBN platform.

Cancellation of Listing

If a PB goes out of business, changes owners, changes products or services, or otherwise needs to cancel its listing before the end of the contract, PB agrees to give IL a minimum of 30 days notice prior to cancellation. PB will receive a refund for the remaining months on the contract within 30 days after the cancellation of the listing.
